Post election crackdown: CBI arrests 6 **Delhi Transport Department officials** in corruption case

NEW DELHI: In a signifi**po**st-election cant crackdown, the CBI has arrested six officials from the Delhi Transport Department on charges of corruption and bribery, marking the first major action in the capital after the Aam Aadmi Party's recent electoral defeat, officials said on Wednesday. The agency had been receiving multiple complaints about rampant corruption within the department, prompting an extensive surveillance operation to verify the allegations before making the arrests, they said.

Following the verification process, investigators found prima facie evidence indicating corruption at various levels.

Earphone use for long hours may cause permanent hearing loss: Health ministry

NEW DELHI: The health ministry has issued a warning against prolonged use of earphones and headphones, suggesting that these devices, whether wired or wireless, should not be used for more than two hours daily. If used for this duration, frequent breaks should be taken during listening sessions. In a letter to all states/UTs

for further dissemination to the public, director general of health services Dr Atul Goel said recent studies have shown prolonged and excessive exposure to loud music and other sounds through personal audio devices can lead to irreversible hearing damage. "Evidence has shown there is a temporary shift of hearing acuity (ability to hear and distinguish sounds) after prolonged use of an

earphone/headphone or

ear plug, which is generally a high-frequency hearing loss that is not easily noticeable in day-to-day life," he said.

"If unsafe use of earphones/headphones/earpl ugs is prolonged and persistent, this shift of hearing acuity can be permanent and result in permanent hearing loss. Certain individuals may also develop a persistent ear ringing or buzzing noise called tinnitus because of prolonged unsafe use," the senior official said.

The young population, Goel said, is at a higher risk due to unsafe listening practices. The rise of online gaming culture is also putting children at risk of exposure to the impulse of high decibel sounds, he added. "Once hearing is permanently impaired, normal hearing will never be restored by hearing aids.

In N. India, short winter doesn't

always lead to searing summer

NEW DELHI: Winter has ended early in north India and February in Delhi is set to be among the three warmest in the last 15 years. So, does the early conclusion of winter indicate a long and scorching summer ahead? Contrary to the general view, data from past years shows that a warm Feb doesn't necessarily lead to a searing summer in north India. monthly average maximum temperatures in north India since 1971 and picked the 10 warmest months of Feb during this period. In five of these years, the corresponding months of April were indeed warmer or significantly than normal but in the other five, April temperatures were either close to normal (four years) or below normal (one year). These two months were chosen for the analysis because Feb is the last month of winter in north India, while April marks the beginning of full-blown.

India's naval advancements will fuel its Indian **Ocean ambitions**

Thailand decided to proceed with the acquisition, underscoring China's persistence in maintaining its naval export commitments. Additionally, Pakistan is set to acquire at least eight Hangor-class submarines and other naval equipment from Beijing, further enhancing China's presence in the region. India has increasingly aligned itself with Western naval powers to address maritime challenges through collaborative efforts. France was among its earliest Western partners, and the countries' cooperation has grown stronger over time. India also participates in joint maritime missions with European nations and European Union Naval Force (EUNAVFOR) initiatives such as Operation Atlanta and Aspides.

Furthermore, India contributes to significant maritime security dialogues such as the Coordinated Maritime Presence (CMP) and Enhancing Security Cooperation In And With Asia (ESIWA). India's 2023 inclusion in the Combined Maritime Forces (CMF), led by the US Central Command, underscores its dedication to enhancing collaborative security in the western Indian Ocean. The IFC-IOR exemplifies India's commitment to collective security, even though it remains a preliminary step toward a more robust maritime security framework. Advancing to the next level will require India to engage in the technically complex task of realtime information sharing through secure legal frameworks beyond Open-Source Intelligence (OSINT). The Quad's Indo-Pacific Maritime Domain Awareness (IPMDA) initiative highlights the challenges in achieving seamless data-sharing capabilities. To counter hybrid threats and protect critical infrastructure, India must prioritise sharing vital intelligence and deploying unmanned systems for coordinated surveillance. Strengthening such partnerships will bolster India's naval capabilities and contribute to broader maritime security across the Indian Ocean Region. The commissioning of new naval platforms marks a significant milestone for India but also highlights persistent challenges, particularly in achieving technological self-reliance in engine manufacturing. Although the INS Surat, INS Nilgiri, and INS Vagsheer were designed by India's Warship Design Bureau and built by Mazagon Dock Shipbuilders Limited, their engines were procured from foreign manufacturers, exposing a critical dependence on external sources. INS Surat, the fourth and final ship of the P15B Guided Missile Destroyer Project, employs a Combined Gas Turbine and Gas Turbine (COGAG) propulsion system. This system uses Me6E and DT-59 reversible engines sourced from Ukraine's Zorya Mashproekt, a key supplier for India's frontline warships. Despite the ongoing war in Ukraine, India has continued to rely on Zorya, underscoring the critical nature of this dependence. To secure the supply chain, Bharat Forge acquired a 51 per cent stake in Zorya's India arm in 2023. Similarly, INS Nilgiri, the first ship of the P17A Stealth Frigate Project, launched in 2019, uses a Combined Diesel and Gas (CODAG) propulsion system. This system incorporates LM2500 engines from General Electric in the US and MAN diesel engines from Germany, further emphasising India's reliance on imported technology despite its strong indigenous design capabilities. INS Vagsheer, the sixth and final submarine of the P75 Scorpene project developed in collaboration with France, also depends on imported MTU diesel engines from Germany. However, the Defence Research and Development Organisation (DRDO) plans to integrate an Air-Independent Propulsion (AIP) system during its mid-life refit, aiming to modernise .

The possibility of an upside earlier expected on the revenue front

With tax revenue growth slowing in the last few months, the possibility of an upside earlier expected on the revenue front may be receding rapidly. Revenue expenditure is also rising at a rate higher than the budgeted 6 per cent. If the fiscal deficit target of 4.9 per cent of gross domestic product (GDP) has to be met for 2024-25, which the government must in view of the uncertainties and challenges emerging both domestically and globally, the finance ministry may see in the composition of the current year's capex a sliver of hope. The finance ministry should not spend ~0.83 trillion for equity infusion into BSNL. Instead, it should ask the telephone company to raise resources from the market. The ministry should also desist from spending the remaining ~0.6 trillion earmarked for capital allocation to new schemes. Saving about ~1.43 trillion (a little less than half a percent of GDP) will be a cushion against other expenditure slippages and revenue shortfall. Not too many tears would be shed for a squeeze on capex if the hit is primarily on infusing equity into a state-owned enterprise and on new schemes that are yet to be announced. Quite ironically, a slowdown in the government's capex may well turn out to be an opportunity.

In contrast, such transfers during the entire 2023-24 had risen sharply by about 24 per cent to ~1.15 trillion. It appears that



these transfers will take a hit in the current year and for the first time since this initiative to help states boost their capex was undertaken a couple of years ago. Significantly, this has not yet adversely impacted the states in a big way. The capex of 25 states (accounting for 95 per cent of all the states' and Union territories' total capex budget) has risen by just about 1 per cent in the April-November 2024-25 period, although states like Andhra Pradesh, Himachal Pradesh, Kerala, Mizoram, Odisha, Telangana, Uttar Pradesh, Uttarakhand, and West Bengal saw their capex fall varying margins. by Eventually, however, this will have an adverse impact on the states' capex programme and its growthenhancing effect. There are two more sectors that account for another 13 per cent of the Centre's capital expenditure budget. But they bring out an intriguing aspect of why the government's capex has been slowing. They suffer from a peculiar problem, which has nothing to do with either the relevant sectors' expen-

diture-absorbing capacity or the absence of effective expenditure monitoring. The bulk of the capex under telecommunications was meant for infusing equity into state-owned Bharat Sanchar Nigam Ltd, or BSNL. Of the total capex of ~0.84 trillion, the proposed amount for BSNL's equity infusion accounted for as much as ~0.83 trillion. But the total expenditure under this head in the first eight months of 2024-25 is only 6 percent of what has been budgeted. In other words, a decision to transfer the equity amount promised to BSNL would increase the government's capex by a significant margin. Why this money has not been transferred is puzzling. Last year, against a budgeted BSNL equity infusion of ~0.53 trillion, the actual infusion was higher at ~0.65 trillion. This year, no action on this front even after eight months is a puzzle as this failure also contributes significantly to the decline in the Centre's capex. More importantly, the Budget for 2024-25 had allocated a significant amount of ~0.66 trillion for capex on central sector schemes and projects. Of this, a large chunk, estimated at ~0.62 trillion, was earmarked for new schemes that the government would announce during the year. However, in the first eight months of the current year, only 4 percent of that total outlay has been used up, leaving ~0.63 trillion yet to be spent. It is likely that the government may not need this amount or it may have kept its powder dry to meet any new schemes that it might announce later in the year, for which such capital allocations will be useful. For the Union finance ministry, currently busy preparing the Budget for 2025-26, such a state of play with regard to slowing capital expenditure could well be an opportunity. The Union government's capital expenditure (capex) continues to be a cause for concern. Of course, the extent of its decline has reduced somewhat — from 35 per cent at the end of the first quarter of the current financial year to 15 per cent at the end of six months. But the latest number for the April-November 2024-25 period shows that the Union government's capex was still 12 per cent lower than what it was in the same period of 2023-24. Instead of aiming for the targeted 17 per cent growth to ~11.11 trillion in capex for 2024-25, the government will have to strive hard to at least cross the figure of ~9.48 trillion reached last year. What has led to this decline? A widely held view is that the seven-phase general elections, which

began on April 19 and ended on June 1 last year, caused a slowdown in capex. But if that indeed is the reason, the decline in capex in the first quarter should have been reversed in the second quarter of 2024-25. And certainly, the first two months of the third quarter should have raised the trajectory of capex growth to a higher level. There has been some improvement, but a 12 per cent decline in the April-November 2024-25 period is no comfort. Look at the slightly different trajectory seen in the Union government's revenue expenditure growth during the same period. The Budget for 2024-25 had projected a rise of over 6 per cent to ~37.1 trillion in revenue expenditure. At the end of June 2024, the growth was just about 2 per cent, but it has been rising since then, reaching 4.2 per cent by the end of the first six months of 2024-25 and climbing even higher to 7.8 per cent during April-November 2024-25. So, if revenue expenditure has gained momentum, why has capex failed to follow suit? A close analysis of the government's capex numbers presents an interesting picture. Over 90 per cent of the Centre's total capex during 2024-25 was accounted for by just six sectors roads, railways, defence, telecom, transfer to states and new schemes. Their share in total capex in 2023-24 was a little less at 87 per cent. But the 12 per cent decline in the first eight months of 2024-25.

That's the tragedy for the daughter of Bangladesh's founding father Sheikh Mujibur Rahman—even her staunchest supporters admit her chances of ever returning to her motherland look very slim. Not just her niece, several other members of Sheikh Hasina's family are also under investigation for corruption that, some estimates say, totals a mind-boggling \$5 billion. The corruption case is linked to an alleged land grab in Dhaka and, more infamously, to a Russian-funded nuclear power plant. In 2013, Sheikh Hasina travelled to Moscow to

seal the deal and was photographed standing beside President Valdimir Putin, Siddig, and other members of her family. When questioned about her presence in Moscow, Siddiq tried to explain it as a family event, but the photo was impossible to dismiss. Apart from family, powerful ministers and industry leaders-allegedly with Sheikh Hasina's blessings or blind eye—also cost Bangladesh billions. A white paper on the economy, presented in Dhaka by a specially appointed finance committee in December, put the cost of corruption across public and private sectors at a staggering

sum. Perhaps the most striking was the claim that "illicit financial outflows averaged \$16 billion annually from 2009 to 2023—more than double the combined foreign aid and FDI inflows." Whether investigations into this immense corruption have yielded documentary evidence or not is open to debate. But for now, Chief Adviser Mohammed Yunus has made his administration's objective clear. "The theft of billions of dollars in public funds has left Bangladesh with a significant financial deficit," Yunus said in a statement this week. "The funds stolen from Bangladesh belong to its people. We will

continue to work with our international partners to ensure that justice is done." Bangladesh's current dispensation has also moved court against Sheikh Hasina on charges of "crimes against humanity." In October, the International Criminal Tribunal (ICT)—that she herself founded—issued an arrest warrant against her and 45 others for the deaths of an estimated 1,000 people in the violence that preceded her ouster on 5 August. "Sheikh Hasina was at the helm of those who committed massacres, killings, and crimes against humanity in July and August.

"We expect continuation and maybe broadening of the PLI support towards the solar module value chain. We already have a few interventions there, which are likely to be extended deeper," Dwivedi said. Similarly, on the battery manufacturing front, the industry expects localization of the value chain given competing countries have already advanced beyond India. In the green hydrogen segment, the industry believes the government may bring in hydrogen purchase for specific sectors like (green) steel. On the EV front, the industry seeks more support towards building public charging infrastructure given the anticipated increase in the EV penetration. "Under the PM E-drive, we already have an allocation of about Rs 1,100 crores for FY26. Given that the final guidelines have not been released until now, I think even the allocation under FY25 may get added and FY26 budget may be increased as the country expects an acceleration in EV adoption in FY26," Dwivedi said. While the government has already launched a rooftop solar scheme and announced viability gap funding for offshore wind projects, industry players expect increased allocations, particularly towards solar and wind, along with higher budgetary capital expenditure in green hydrogen and battery storage infrastructure. Along with this, the sector also expects the government to increase its coverage of households under PM Suryaghar. "Under the Atmannirbhar Bhart scheme, there should be a scheme for the home grown EPCM companies to create indigenous technical capabilities in the country and reduce the

tion in import duties on chemicals in India," said Umesh Sood, CEO Simon India Ltd. Sunil Singhvi, President, Indian Electrical and Electronics Manufacturers Association noted that there is a need for strong policy support to foster growth, drive innovation, and enhance sustainability in the power sector. "One of the main requests is to expand the PLI scheme, which aims to increase domestic production of crucial electrical components necessary for large and essential power projects, such as the advanced High Voltage Direct Current (HVDC) systems." he said. Extension of the Production Linked Incentive (PLI) scheme for solar energy value chain, increased allocation towards PM Suryaghar Muft Bijlee Yojana, and greater thrust to distribution and transmission infrastructure are likely to be the key features of the upcoming Budget, as far as the energy sector is concerned. Sources said these proposals figured not only in the budget wish lists of the industry, but also in the respective recommendations from the ministries of power and renewable energy to the finance ministry , ahead of the Budget. "Given the success of PM Suryaghar scheme with almost 600,000 installations in just nine months since its launch, one could probably see additional allocation to target more households," said Ashwin Jacob, partner at Deloitte India. "As far as evacuation of power from offshore wind projects is concerned, we would want to see the VGF or budgetary support to continue or get enhanced," he added. "We hope to see a decisive increase in funding to accelerate the green energy transition. Priorities must include scaling renewable energy by addressing grid and transmission challenges, advancing Battery Energy Storage

Over 45% of Himachal at risk of landslides, floods: IIT



DEHRADUN: Over 45% of Himachal Pradesh's area is highly prone to natural disasters such as floods, landslides, and avalanches, according to a study by researchers from Indian Institute of Technology (IIT), Ropar. The team recently completed a hazard susceptibility mapping of the state as part of a broader effort by researchers and scientists from multiple IITs to assess multi-hazard vulnerability across the Himalayan states. The goal is to identify regions at high risk from multiple natural hazards simultaneously and aid in targeted disaster risk reduction

strategies. The IIT Ropar team presented its findings at the 2nd Indian Cryosphere Meet (ICM), held at IIT Bombay on Feb 14-15, which was attended by nearly 80 glaciologists, researchers, and scientists from around the world.The study, conducted by MTech scholar Daishisha lawphniaw under the guidance of Reet Kamal Tiwari, an associate professor at IIT Ropar, used geospatial data to evaluate the state's vulnerability. Tiwari told TOI, "The study found that areas with mean slopes between 5.9 degrees and 16.4 degrees and

elevations up to 1,600

metres are particularly prone to both landslides and floods. Meanwhile, higheraltitude regions with slopes between 16.8 degrees and 41.5 degrees are more likely to experience both avalanches and landslides." He added that steep mountain slopes and elevations above 3,000 metres are at the "highest risk". Using GIS-based mapping, the study classihazard-prone fied regions, showing that flood and landslideprone zones are typically located in lowerelevation river valleys, while high-altitude mountains face a greater threat of avalanches.

NEW DELHI: The Indian Army opened a retaliatory firing at the Pakistani troops across the Line of Control (LoC) on Sunday.

The incident occurred in Jammu and Kashmir's 11 am.

"At about 11 AM today, Pakistan troops opened small arms fire on own (Indian) post across LoC in Poonch Sector, J&K. The fire was retaliated appropriately by the Indian Army. No casualties to own side," the Army officials told news agency ANI.

On February 8, terrorists fired at a patrol from a forested area across LoC in Keri sector of Rajouri, prompting a retaliatory response from Indian ed that of the 70 to 80 soldiers.

Register all live-in relationships

Delhi: Justice Anoop Kumar Dhand ordered the state government and Union social welfare and justice secretary to create a legislative format for registering live-in couples by March 1.The HC requested a plan to hold male and female partners accountable for the education, health, and upbringing of their children. The male partner must also be held responsible for supporting his non-earning female partner and their children, the court ruled. The single bench asked the chief justice to form a larger bench to explore the issue of protecting married people cohabiting with remarried partners or married people from separate marriages living together without dissolving their marriages. The Rajasthan High Court ordered that live-in relationships be registered by a government entity or tribunal until the Union and state governments legislate.

Delhi's 180cr Allocation Boost

Delhi: The Union Budget for 2025-26 allocates Rs 1,348 crore to Delhi. It's Rs 180 crore more than the 2024-25 Rs 1,168 crore allotment. The capital has been provided with Rs 968 crore as grant-inaid and Rs 380 crore as loans and advances. Unlike last year, there is no specific provision for the disaster response fund, the externally funded Chandrawal water treatment plant, or increased compensation for the 1984 riot victims. New Delhi: A US military aircraft landed at Amritsar airport on Saturday night, carrying 116 Indian migrants who had been deported from the United States. Among them was Daljit Singh, who had left his village in Punjab last year with hopes of a better future. Instead, he returned in shackles, his hands cuffed and legs chained throughout the journey.

"Our legs were chained and hands were also cuffed throughout the journey. There were three women and three children on board who were not cuffed," Daljit told news agency PTI upon arrival. His experience reflects the harsh reality of illegal migration, where many fall prey to fraudulent travel agents and endure gruelling journeys, only to be deported back home. Among the deportees, over 60



were from Punjab, 33 from Haryana, eight from Gujarat, two each from Uttar Pradesh, Goa, Maharashtra, and Rajasthan, and one each from Himachal Pradesh and Jammu

Three years of preparation, Rs 5000 crore investment, helped railways run over 17,000 trains for Maha Kumbh

NEW DELHI: Three years of preparation ahead of Maha Kumbh with an investment of Rs 5,000 crore to upgrade infrastructure and streamline maintenance helped the railways to run over 17,000 trains in 45 days, four times more than the last Kumbh, without a single instance of failure of locomotives, track or overhead wires.

During the Maha Kumbh period, around 4.5-5 crore people took trains for Prayagraj, railway minister Ashwini Vaishnaw said on Thursday while giving details of the preparation, coordination and execution to run the record number of trains. This was the largest train operation for any festival in the railway's history. To run more passenger trains, all freight trains were shifted to the Dedicated Freight Corridors, officials said. Vaishnaw, who visited Prayagraj, lauded the seamless coordination between different departments. He said while the original goal was to operate around 13,000 trains, the railways managed to run 16,000 trains without any problems. "Every train operated effectively, guaranteeing devotees a hassle-free trip," he said. 

NEW DELHI: Renewing the same class of US visa could now mean a long wait for many applicants in India. Sam Uncle has returned to its pre-Covid policy of allowing travellers to renew their visa without appearing at the embassy/consulate for an interview if their previous same-class visa is still valid or expired within the last 12 months. In Nov 2022, when the wait time for B1/B2 (business and tourism visa) interview had crossed 999 days (touching almost three years) in India, the US increased the eligibility for same class drop box visa renewal — which does not require interview - from 12 months to 48 months. Since then the waiting period for B1/B2 interview has less than halved, it is currently over 440 days in Delhi &

BATHINDA: Paramjit Singh, aka Saurav, set off from his native village of Chandiwala in Punjab's Ferozepur on December 17 last year, his mind a welter of emotions. The 23-year-old's family had sold two acres and taken a loan to raise the Rs 45 lakh he needed to pay an immigration agent for illegal passage to US. They knew the journey was fraught with peril, but promise of a prosperous life was too strong to resist. As he bade goodbye to his loved ones. Saurav told himself he couldn't fail them. Two months later, he is back in Chandiwala, a physical and mental wreck. The money is gone, and his illusions lie shattered. "The last 40 days

were the toughest. I saw how a life choice you make can become your biggest enemy," said Saurav, among the 116 illegal Indian immigrants

JIND: Ravi, a resident of Haryana's Jind, faced a 220-day ordeal even after payment of around Rs 35 lakh to an unauthorised travel agent to reach the US. Of this, Rs 6 lakh was forked out by his family after the 26-year-old was starved in the jungles of Panama and allegedly taken hostage. Ravi had travelled

across ten countries, spent a few months in the jungles, and jumped over a wall to reach the US about 20 days ago, only to be caught and deported.

Commercial LPG hike by Rs 16.5 per cylinder, jet fuel up 1.45%; household cooking gas remains unchanged

NEW DELHI: The cost of commercial LPG and aviation fuel prices surged on Sunday following the monthly revision aimed at aligning with trends in international oil prices. State-owned oil firms raised commercial LPG rates, used in hotels and restaurants by Rs 16.5 per to Rs 1818.50 per 19 kg cylinder. Aviation turbine fuel (ATF) prices in Delhi, which hosts one of India's most active airports, saw an increase of Rs 1,318.12 per kilo litre, marking a 1.45 per cent increment. The new rate stands at Rs 91,856.84 per kl, according to state-owned fuel retailers. The prices of ATF and LPG vary from state to state, depending on local taxes, including VAT. This marks the second consecutive monthly increase in jet fuel prices, which were previously raised by Rs 2,941.5 per kl, or 3.3 per cemt, on November 1. ATF prices were reduced by 6.3 per cent (Rs 5,883 per kl) on October 1 and by Rs 4,495.5 per kl, or 4.58 per cent, on September 1. In Mumbai, the ATF price increased to Rs 85,861.02 per kl on Sunday from Rs 84,642.91 previously. The price of commercial LPG have also increased for the seventh consecutive month. In the most recent review on November 1, commercial LPG prices were raised by Rs 62 per 19-kg cylinder. Over the course of five price hikes, commercial LPG prices have increased by Rs 172.5 per 19-kg cylinder, reaching their peak this year. Four monthly price reductions before the current cycle began in August were offset by the recent hikes. Prices for 19-kg cylinders were reduced by Rs 148 across the four rounds. Currently, commercial LPG costs Rs 1,980 in Chennai, Rs 1,927 in Kolkata, and Rs 1,771 in Mumbai for a 19-kg cylinder. However, the rate of cooking gas used in domestic households, however, remained unchanged at Rs 803 per 14.2-kg cylinder. State-owned Indian Oil Corporation (IOC), Bharat Petroleum Corporation Ltd (BPCL), and Hindustan Petroleum Corporation Ltd (HPCL) revise the prices of ATF and cooking gas on the first of each month.

For two young Goans who had left for the US only last month, this dream came crashing as they sat

shackled and handcuffed on a US C-17 military transport aircraft on Saturday during their disconsolate journey back to where they started: home. Sarzora lad AC Mascarenhas, in his twenties, found his hopes crushed even before he could make it to US soil. His dangerous trek through several countries and his audacious plan of being smuggled by human traffickers in pursuit of the American dream ended at the US bor-

der. For company, he had a compatriot from Shiroda, G Souza. The two returned home quietly on Sunday, accompanied by Goa cops. This was the first instance of Goans being sent back in handcuffs with their legs chained during the flight. "It's unfortunate that Goan youths were part of the group deported. They can't get jobs here, which is why they go to find jobs abroad. Time for govt to study why youths risk their lives.

Punjab cop's son paid Rs 80L to reach US



A married couple who spent Rs 80 lakh to reach the US was arrested on arrival and deported. They landed in Amritsar Saturday night on the second US deportation flight and reached their native place at Lalru in Punjab's Mohali district on Sunday.

Gurpreet Singh (30) and Amanpreet Kaur (26) got married a year-and-a-half ago, left the country soon after and kept wandering from one country to the other for nine months before American immigration agents arrested them as soon as they entered that country. Gurpreet's father Jaswinder Singh is a Punjab cop. Gurpreet and Amanpreet, who hails from Haryana's Shahzadpur, are the second couple from Mohali to have been deported from the US.

The couple are traumatised and unwilling to reveal details of their nine-month-long route to the US. The family is now worried how to get Rs 80 lakh, paid to an agent in Haryana, back.

If India adopts hybrid model

Delhi: The Pakistan Cricket Board (PCB) has softened its stance, saying they will accept the 'hybrid format' for the Champions Trophy if the ICC does the same for global events in India until 2031. India will host the 2026 T20 World Cup alongside Sri Lanka, the 2029 Champions Trophy, and the 2031 ODI World Cup with Bangladesh till 2031. The PCB had threatened to boycott the Champions Trophy if Pakistan was not handed full hosting rights, but this has eased its position. India will likely play in Dubai if the Champions Trophy is hybrid. "The current situation is that PCB Chairman Mohsin Naqvi has said that it will only accept hosting the Champions Trophy on a hybrid model if the board agrees that in the future all ICC events will be on the same system with Pakistan not going to India to play matches, "Pakistan also wants the ICC board to increase its financial cycle share of revenues from 5.75 percent and Naqvi is insistent on this but he has not sought any additional hosting fees," a source said. "People are saying that Naqvi has sought time to get back after talking to his government but we don't know if he went there with the backing of the government and had already sought their approval to make his stand in the ICC board's virtual meeting," he said. The standoff between India and Pakistan's cricket bodies threatens the eight-team Champions Trophy in Lahore, Rawalpindi, and Karachi. The BCCI has informed the ICC that it would not send its side to Pakistan for the February-March 2025 Champions Trophy. The PCB-BCCI dispute continues. The ICC Board Meeting failed to resolve the tournament's destiny. After the BCCI informed the ICC that India would not tour Pakistan, the PCB wrote to the ICC to ask why. PCB chairman Mohsin Naqvi said he would support the hybrid format because the tournament will be played in Pakistan. Pakistan will host the Champions Trophy from February 19 to March 9

Exam centers to get CCTVs from **NIOS to reduce malpractices**

Delhi: To ensure transparent and seamless assessments, the Board of Secondary Education (BSE) will use AI-powered CCTV cameras and webcasting of the annual High School Certificate (HSC) exam 2024. Pauses, violations of rules, such as logistical issues in storing or distributing question papers,

cheating, malpractice, invigilator incompetence, or cell phone use in HSC exam centers, can now be identified quickly. The board has strategically placed AI-sup-



ported CCTV cameras and webcasting for realtime test hall surveillance. Advanced features in these cameras can detect strange behavior in the medical room. "The annual matric examination 2024 will be completely hi-tech and technologyenabled to make the process transparent and error-free," stated BSE secretary Nihar Ranjan Mohanty.

Over 5.5 lakh students will take the yearly HSC exam from February 20 to March 4, 2024. More than 2,990 centers will host the exam this year. Hypersensitive and sensitive test centers, strong rooms where question papers will be maintained, and district education officers will have AIenabled CCTV cameras. "We are working on identifying the centres based on the reports of DEOs," he said. The BSE sends a three-tier squad of 160 persons to examination centers to check for wrongdoing and ensure smooth board exams.
